

8. Allottee will obtain all the necessary permissions and clearances etc. from requisite Department/Agency as is necessary according to law, rules and regulations in force. This will also apply in case of relevant amenities/facilities that the allottee may need for their project. However, in case of any problem the allottee may approach this Authority, which will provide all feasible and available assistance to the Allottee in procurement of the subject amenities/facilities.
